

**FRANKLIN SQUARE UNION FREE SCHOOL DISTRICT
SPECIAL TRANSPORTATION REQUEST FOR 2021-2022 SCHOOL YEAR**

The Education Law* sets April 1, 2021 as the deadline for accepting requests for student transportation to private, parochial, and schools for handicapped children in the coming year. A request form must be completed for each child attending a non-public school and all forms are to be signed by a parent or guardian.

Under this policy, the Board of Education offers transportation to any non-public school within fifteen (15) miles by the nearest route from the student's home. Kindergartens through third grade students are transported if they reside more than one-half mile from school. Fourth through sixth grade students are transported if they reside more than one mile from school. Handicapped children are transported in conformity with law and the Commissioner of Education's regulations.

We need information requested on the form below in order to establish our transportation budget and schedule of service for your child. Any early response will be appreciated.

We realize that sometimes the final acceptance to a school is not made *until later in the year*. If you plan or contemplate having your child attend a private or parochial school during the 2021 - 2022 school year, you must file a request for transportation by April 1, 2021.
